Note :- (7) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O. (P) no.81/09/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahasildar along with other documents at the time of OTR verification of original documents. Candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (8) According to the existing procedure rechecking and revaluation of answer scripts are not allowed. Detailed instructions will be published in the Ranked List to be published for the post. Scanned image and Tabulation sheet of answer scripts of the Descriptive Test held on **03-12-2024** will be issued to the candidate who, apply for the same remitting the prescribed fee after approval of the Ranked List.
