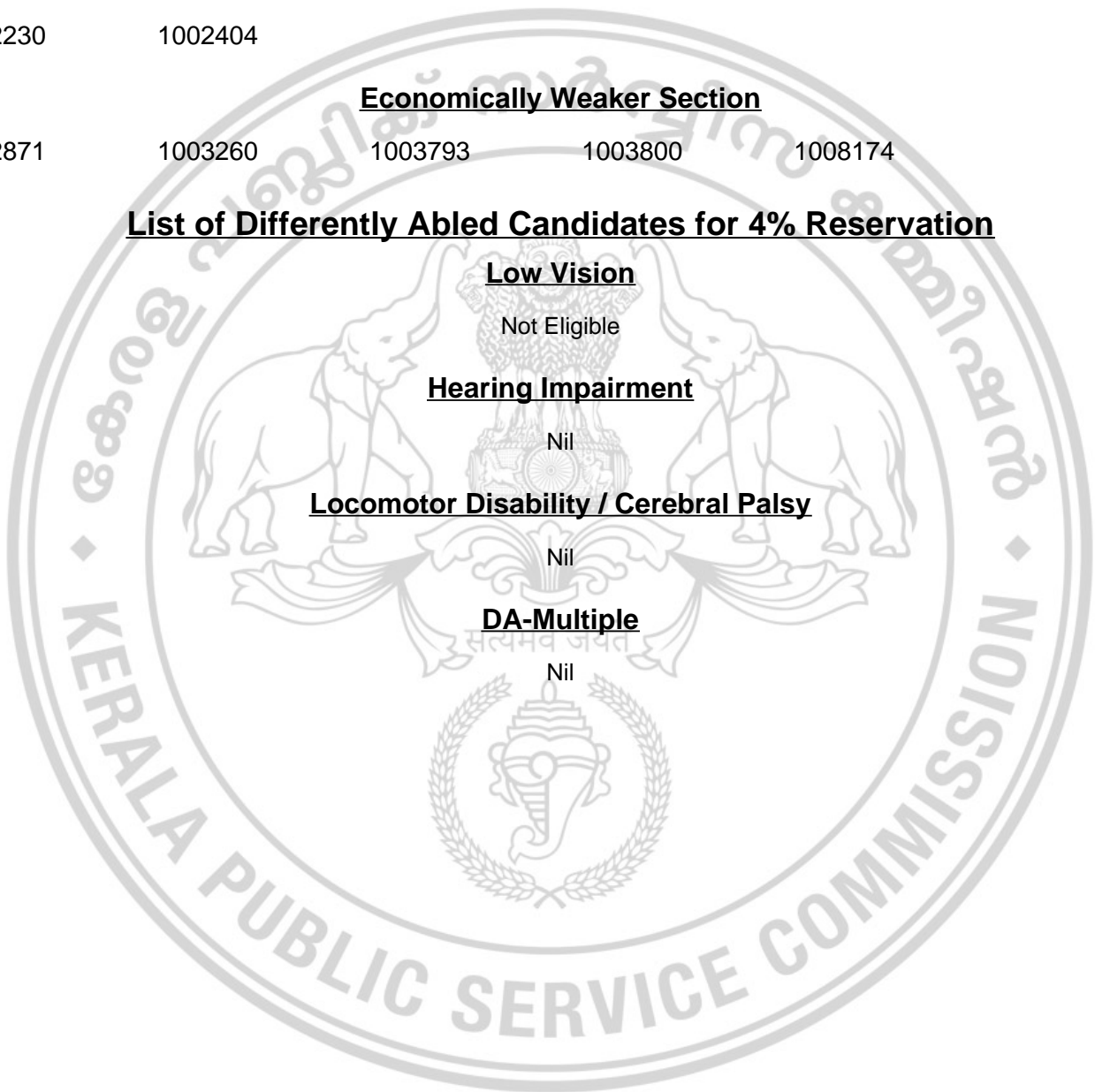

For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste,,Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (3) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. Date,time and Venue of OTR Verification and Interview will be published shortly.

Note :- (4) The Short List is prepared based on the details furnished by the candidates in the application and subsequent claim will not be entertained at any stage.

Note :- (5)According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to other backward classes included in the Short List are required to produce Non Creamy Layer Certificate, as per G.O(P) No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in G.O(Rt) No 3942/2018/RD dated 24.09.2018, and SC/ST candidates are required to produce Community Certificate issued by the Revenue Authority and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on 25.04.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated for the above mentioned post as per Invalidation Notification No : ER 16-2/6/2025-KPSC dated 21.06.2025 of KPSC Secretary.
