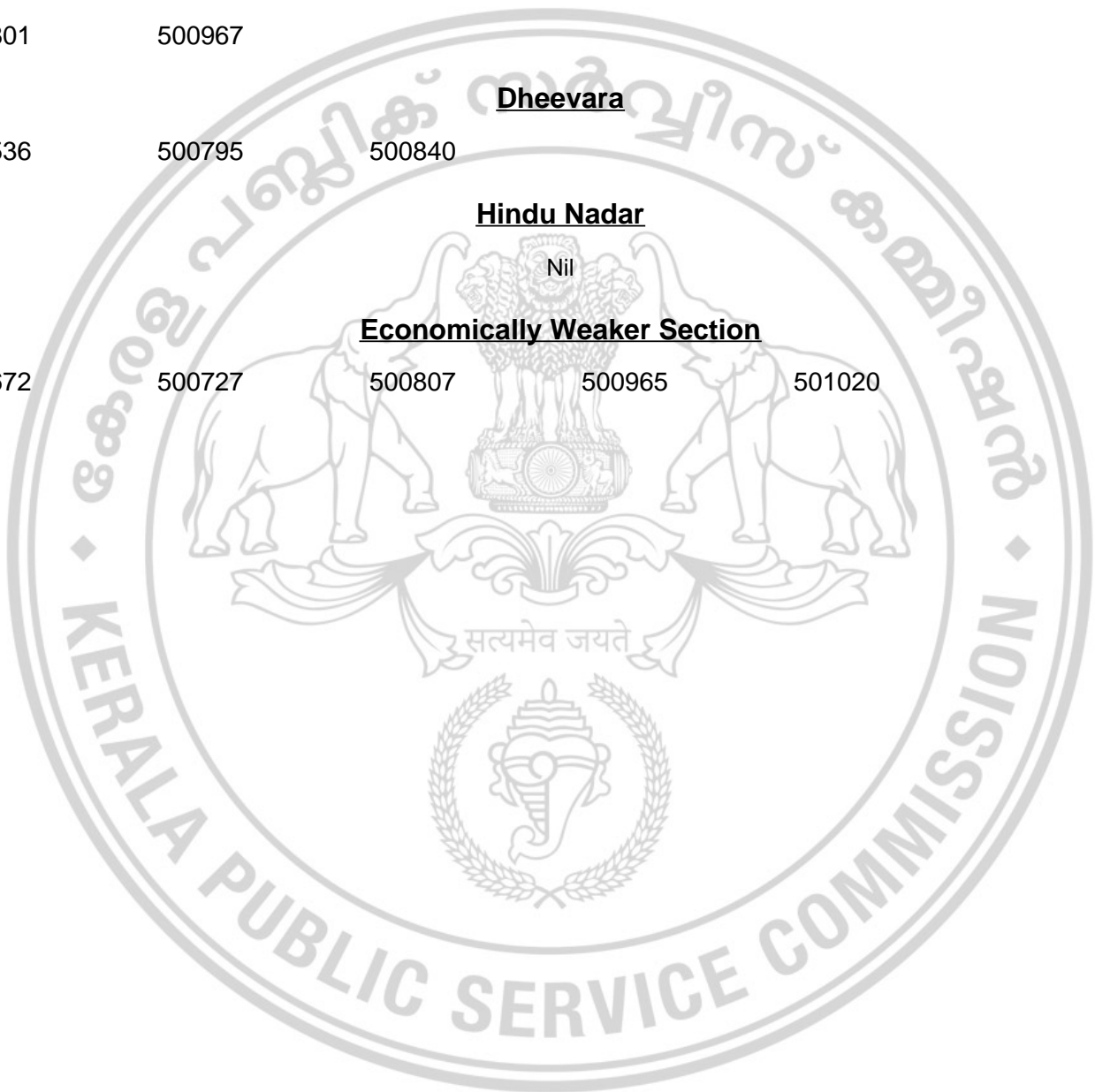

Note :- (2) The list has been prepared by including the number of candidates who have secured top marks in the Descriptive Examination held on **26/09/2023**.

Note :- (3) The Short List is prepared based on the number including the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (4) 31 (Thirty One) candidates who have secured top most marks in the Descriptive Examination are included in the Main List of this Short list. The marks secured by the last candidate in the Main List is **35.25 (thirty five (point) Two five)**. For the purpost of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary supplementary lists are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date, time, Venue of OTR Verification and interview of candidates included in Short List will be intimated in due course.**

Note :- (6) According to the existing procedure, revaluation and rechecking of answer scripts are not allowed. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) andidates belonging to Other Backward Classes included in the Short List , eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O (P) No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in G.O (Rt) No.3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate (Form III/ Digitally signed) issued by the Revenue Authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.3/2024/P&ARD dated 25.04.2024 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (8) The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (9) Scanned image and Tabulation sheet of answer scripts of the Descriptive Test held on **26.09.2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Answer script is invalidated as per Notification number ER 2-3/10/2024 KPSC dated 04.04.2025.
