**Note :- (4)** Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. Date,time and Venue of OTR Verification and Interview will be published shortly.

**Note :- (5)** The Short List is prepared based on the details furnished by the candidates in the application and subsequent claim will not be entertained at any stage.

**Note :- (6)** The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short list without further notice.

**Note :- (7)** According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

**Note :- (8)** SC/ST Candidates included in the Short list are required to produce Community Certificate( Form III/Digitally signed) issued by the competent Revenue Authority, Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009 and those belonging to Economically Weaker Section are required to produce EWS Certificate as per G.O(MS) No.3/2024/P&ARD dated 25/04/2024 (Annexure II or IV) in proof of their claim along with other relevant documents at the time of OTR Verification.

**Note:- (9)** Copy of answer scripts of the OMR Test held on 25.4.25 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER 16-2/6/2025-KPSC dtd 21/06/2025
