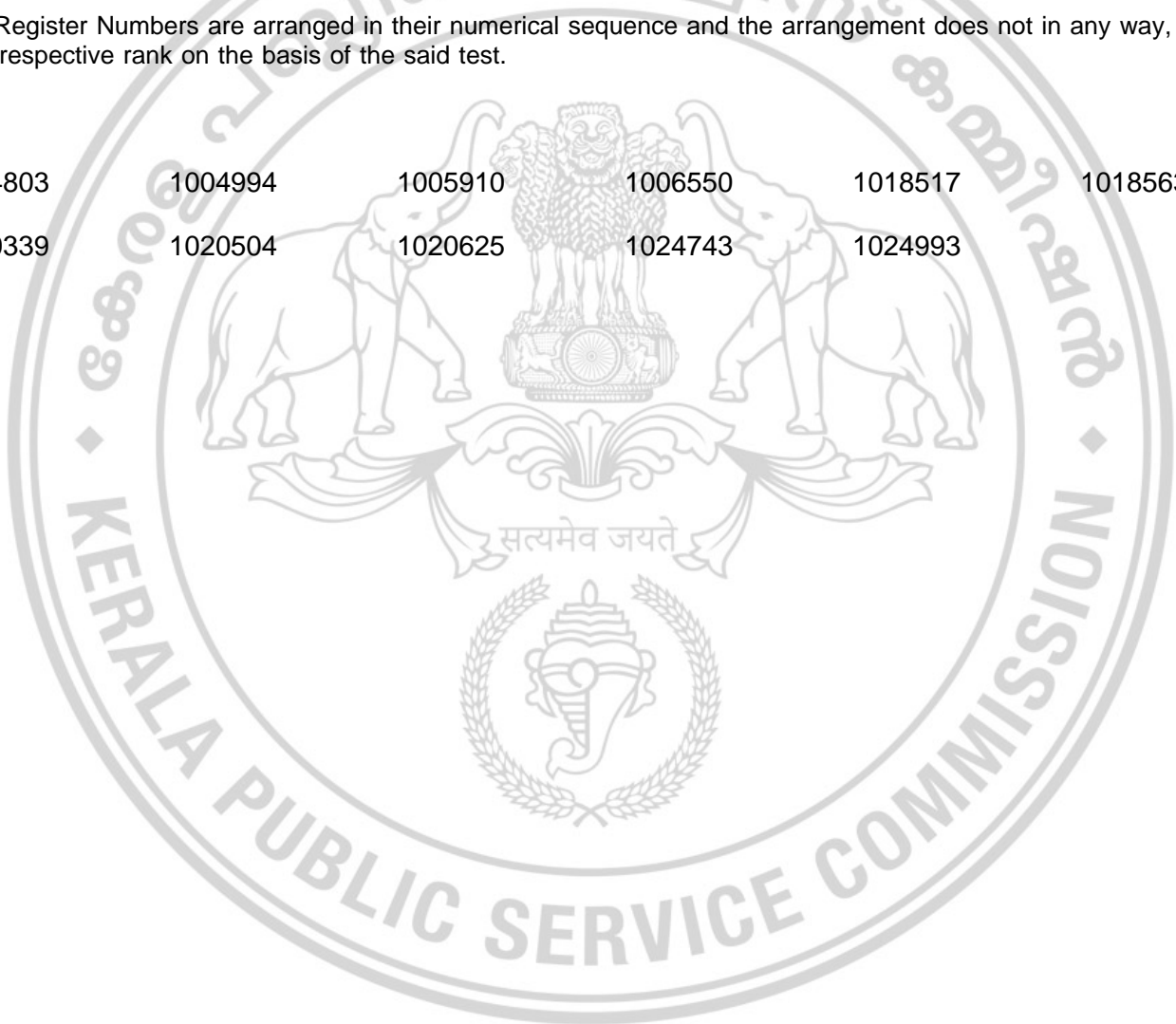

Note (7) :- According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note (8) :- Candidates included in the Probability List are required to produce the Community Certificate from the Revenue Authority in the prescribed format at the time of OTR Verification.

Note (9) :- Copy of answer scripts of the OMR Test held on 26-04-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after publication of the Ranked List. Answer script of no candidate is invalidated as per Notification No : ER 2-1/5/2025-KPSC dated 27.06.2025.
