The Marks secured by the last candidate in the Main List is 73.67 (Seventy Three Point Six Seven) marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes , Other Backward Classes and Economically Weaker Sections(and other reserved categories if any) necessary supplementary lists are prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4)Candidates included in the Short List should present and produce in person the original documents for OneTime Verification & Interview. Date, time and Venue of OTR Verification & Interview will be intimated through profile message & SMS in due course.

Note :- (5) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SCSTDD dated:26.09.2009, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahasildar and candidates who claim EWS reservation are required to produce EWS Certificate vide GO(Ms) No. 23/2020/P&ARD Dtd.12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR verification.

Note :- (6) For Online Examination, rechecking and revaluation are not allowed, but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List.Detailed instructions will be furnished in the Ranked List to be published for the post.
