Note :- (7) Candidates included in the Short List who are eligible for reservation for Other Backward Classes are required to produce Non Creamy Layer Certificate (for state employment purpose) obtained from Village Officer and candidates who claim EWS reservation are required to produce EWS Certificate as per vide GO(P)No.3/2024/P&ARD dated 25.04.2024 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.
