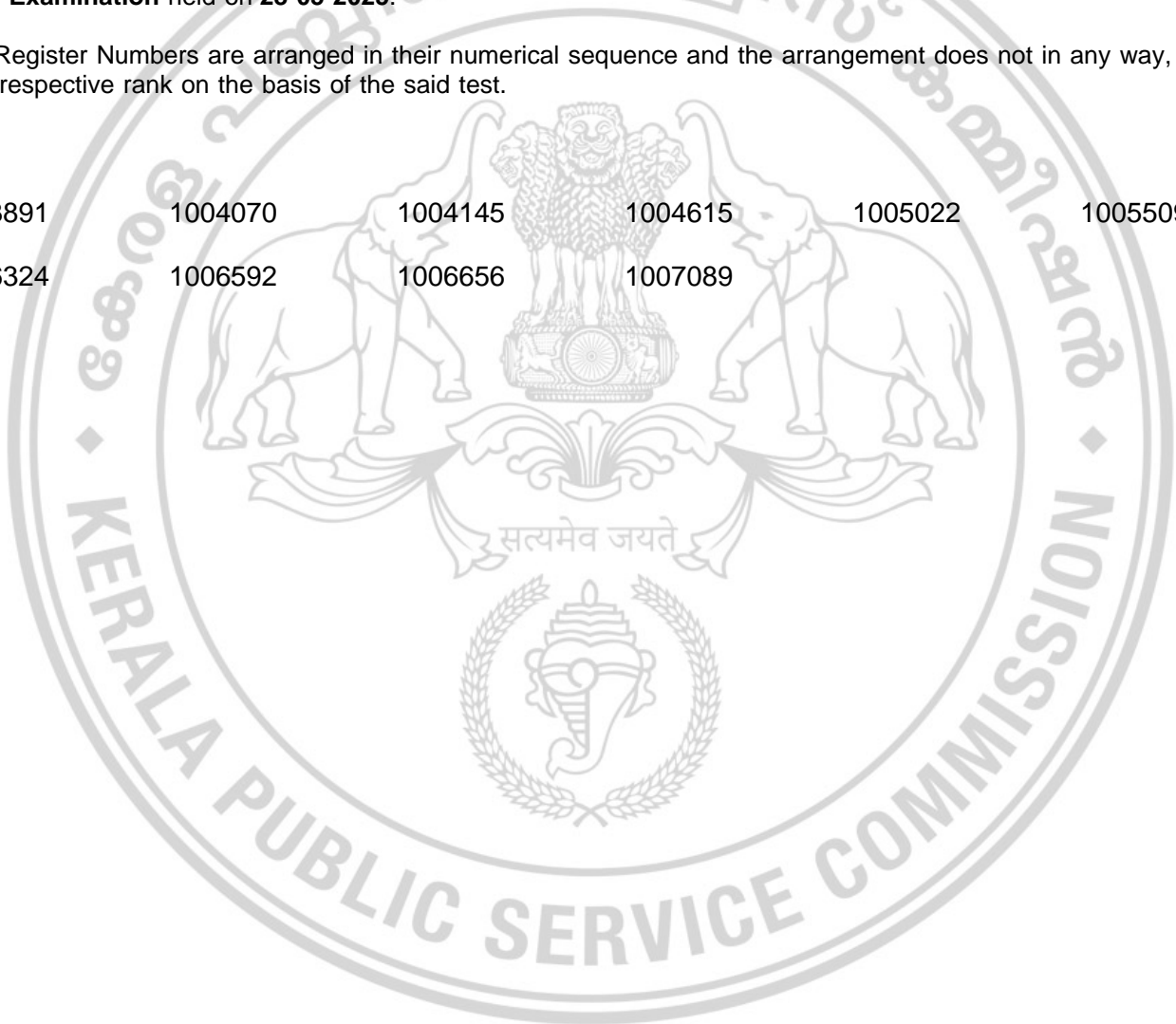

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List.

Note :- (7) Copy of answer scripts of the Common OMR Test held on 28.05.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee only after publication of all the Ranked Lists of those posts for which the candidate has participated. Detailed instructions will be incorporated in the Ranked List to be published for the post.
