

The following is the list of the candidate for selection to the post of CSR Technician Gr.II / Sterilisation Technician Gr.II Third NCA - OBC (Cat No. 411/2024) on Rs. 26,500 - 60,700/- in Medical Education Department, found suitable by the Commission based on the Common Online Examination held on 16.07.2025 for recruitment against the NCA vacancies for OBC community only. NOTE (1):-For Online Examination rechecking and revaluation is not allowed. Candidates who wish to obtain print out of Answer sheets to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs.335/- (Rupees three hundred and thirty five only) via e-payment mode available in the portal. A period of 15 (fifteen) days time to apply for printout of answer sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (i.e on or before **25/09/2025**). Application submitted in any other manner i.e email/Tappal/by hand will not be considered. A printout of Answer sheets will be issued only once to a candidate. Please note that in the case of Ranked List of those posts for which common examinations were conducted, the copy of answer sheets will be provided only after the publication of all the Ranked Lists of those posts for which the candidate has participated.

NOTE (2):- The entries put in column (8) are based on the Community specified by the candidate in his Application form and proved by him with necessary documents. If the candidate's Community has not been correctly noted in the Ranked List as proved him in his Application should intimate the fact to the Deputy Secretary (Examinations) -III, Kerala Public Service Commission, Thiruvananthapuram -695004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (3):- If the candidate wishes to relinquish his claim for advice from the Ranked list, he should submit an application in the format prescribed by the Commission to THE SECRETARY, KERALA PUBLIC SERVICE COMMISSION HEAD OFFICE, PATTOM, THIRUVANANTHAPURAM-4. The format is available in the official website of the Commission. The request for relinquishment, if not in the format prescribed by the Commission will not be honoured under any circumstances. The candidate can relinquish his right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of the ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment along with the original of notarized affidavit and a self attested copy of the ID proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy based on which he is to be advised.
