**NOTE (4):** Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit an online application through their One Time Registration profile from the official website of the Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) by remitting the prescribed fee of **Rs. 335/- (Rupees Three Hundred and Thirty Five only)** via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded on the website of the Commission (on or before **02.10.2025**). Applications submitted in any other manner will not be considered. A copy of the Answer Sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued. Please note that in the case of Ranked Lists of those posts for which common examinations were conducted, the copy of OMR Answer Sheets will be provided only after the publication of all the Ranked Lists of those posts in which the candidate has participated.

**NOTE (5):** The entries put in **Column (5)** are based on the **Communities specified by the candidate** in their application forms and proved by them with necessary documents. The request in the prescribed format should be duly attested by a **Gazetted Officer of State/Central Government** with signature, name, designation and office seal, along with a **notarized affidavit** and **self-attested copy of an ID proof**, received within **15 days** from the date of publication of the Ranked List on the official website of the Commission. Such requests will be honoured against requisitions of vacancies pending with the Commission up to the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received **on or before the date of receipt of requisition** based on which the candidate is to be advised.

**NOTE (7):** Since a **common OMR Test with common candidates** was conducted for this post, the marks awarded to the candidates included in this Ranked List and the marks of the OMR Test relating to all candidates who appeared for the test will be published only after the publication of the **entire Ranked Lists (including NCA Notifications)** which will be finalised on the basis of the common test.

**NOTE (8):** The result of rechecking of OMR Answer Scripts will be intimated in due course. However, photocopies of the OMR Answer Scripts will be issued only after the publication of all the Ranked Lists for all those posts for which the candidates has participated .

**NOTE (9) :**The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of all Ranked lists.
