Note:- (2) The list has been prepared by including the eligible and qualified candidates who have secured top marks in the OMR Test held on 25.07.2025.

Note :- (3) 15 (Fifteen) candidates who have secured top marks in the OMR Examination are included in the Main List of this Probability List. The mark secured by the last candidate in the Main list is 65(Sixty Five) Marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribes, Other Backward Classes (and the other reserved categories if any) , necessary Supplementary List is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be published shortly.**

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SCSTDD dated:26.09.2009, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of a Tahasildar and candidates who claim EWS reservation are required to produce EWS Certificate vide GO(Ms) No. 23/2022/P&ARD Dtd.04.10.2022 issued by the Revenue Authority along with other documents at the time of OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 25-07-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated for this post as per Notification No : ERI-2/4/2025-KPSC dated. 08/10/2025.
