Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of Physical Measurement, OTR Verification will be published shortly.**

Note :- (5) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates included in the Short List are required to produce Non Creamy Layer Certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **12-07-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ER 16-3/10/2025-KPSC Dated 23.09.2025 .
