Printout of the answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for printout of the answer sheet which is not their own,and legal proceedings will be initiated against those who do so. "Please note that in the case of Ranked Lists of those posts for which common examinations were conducted, the print out of Answer sheets will be provided only after the publication of all Ranked Lists of those posts for which the candidate has participted".
