The marks secured by the last candidate in the main list is **56 (Fifty Six)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Sections (and other reserved Categories if any) , necessary supplementary lists are prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present in person and produce the original documents for One Time Verification and Interview. Date,time, Venue of OTR Verification and Interview will be intimated through profile message & SMS in due course.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who belong to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/09/SC/STDD dated. 26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahasildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per GO(Ms) No.3/2024/P&ARD dated 25.04.2024 along with other documents at the time of OTR Verification.

Note :- (7)The Register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (8) Copy of answer scripts of candidates who have appeared for the OMR Test held on 04-08-2025 for the post, will be issued to those candidates who apply for the same remitting the prescribed fee after the publication of the Ranked List. Candidate whose Register number invalidated is advised to refer to the Notification No : ER7-2/12/2025-KPSC DATED: 18/10/2025 of the Secretary, KPSC.
