The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of **15 (Fifteen)** days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which the Ranked list is uploaded in the website of the Commission (ie. on or before **25.11.2025**) .Rechecking of answer scripts invalidated due to any defects will not be considered.

**NOTE (3)**:- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online Application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of **Rs.335/- (Rupees Three Hundred and Thirtyfive Only)** via e-payment mode available in the portal. A period of 15 **(Fifteen)** days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission (ie. on or before **25.11.2025**). Applications submitted in any other manner will not be considered. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Please note that in the case of Ranked Lists of those posts for which common examinations were conducted, the copy of Answer sheets will be provided only after the publication of all the Ranked Lists of those posts for which the candidate has participated.

**NOTE (4)**:- The entries put in column (8) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidates whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to **The District Officer**, **Kerala Public Service Commission**, **District Office**, **Kottayam - 686004** within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

**NOTE (5) :-** The Candidates who wish to relinquish their claim for advice from the Ranked list shall submit an Application in the format prescribed by the Commission to The District Officer, Kerala Public Service Commission, District Office, Muttambalam P O, Kottayam, 686004, duly attested by a Gazetted Officer of State / Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General Conditions. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the Relinquishment Application in the format prescribed by the Commission will not be honoured under any Circumstances. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official

website of the Commission (ie. on or before 25.11.2025) will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. In the case of the requisition of vacancies received after the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
