**NOTE (1)**:-10% of the Vacancies in the cadre of Lower Division Clerk will be reserved for persons working in any of the lower categories included under the Kerala Water Authority (Administrative, Ministerial and Last Grade) Service Rules 2011 or Kerala Water Authority Public Health Engineering Service Rules / Kerala Water Authority Technical Special Rules holding posts within the purview of the commission. The names of low paid employees who secure 40% marks and above in the selective test conducted by the Public Service Commission and thus became qualified for appointment as Lower Division Clerk, but could not secure appointment before the expiry of the ranked list will be included at the top of the new separate ranked list of Low paid employees irrespective of their service and seniority and they will be given appointment accordingly.

**NOTE (2)**:- For Online Examinations, rechecking and revaluation of answer scripts are not allowed. Candidates who wish to obtain a print out of their Answer sheets to this selection shall submit an online application through their One Time Registration profile from the official website of the Commission, 'www.keralapsc.gov.in' by remitting the prescribed fee of Rs.335/- (Rupees three hundred and thirty five only ) via e-payment mode available in the portal . A period of 15 (fifteen) days time to apply for the printout of answer sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the official website of the Commission.(i.e on or before 04.12.2025) Application submitted in any other manner ie email/Tappal/by hand will not be considered. A printout of the answer sheets will be issued only once to a candidate.

NOTE (3):- Candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to The Secretary, Kerala Public Service Commission Head Office, Pattom, Thiruvananthapuram - 695004. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a Notarized Affidavit and a self attested copy of an ID-Proof bearing photograph as enlisted in the General conditions. The request for relinquishment along with a Notarized Affidavit and a self attested copy of the ID Proof received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised.

**NOTE (4)**:- Since a common Online Examination with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of Online Examination relating to all candidates appeared for the examination will be published only after the publication of entire Ranked Lists which will be finalised on the basis of the common test. Print Out of the Online answer scripts will be issued only after the publication of all the Ranked Lists of those posts for which the candidate has participated.

**NOTE (5)**:- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of all Ranked Lists included in the Common Online Examination.
