Note :- (4) A Physical Measurement ,Physical Efficiency test and One Time Verification will be conducted for candidates included in the Short List. Date, Time and Venue of Physical Measurement and Physical Efficiency test will be intimated to the candidates shortly through their OneTime Registration Profile, phone messages, Electronic and print media. Candidates should download their Admission tickets for the above test and should appear in person with their original documents.

Note :- (5) Candidates included in the Short List are required to produce Community Certificate issued by the Revenue authority and Service Candidates should produce Service Certificate from the department along with other documents mentioned at the time of OTR verification of original documents.

Note :- (6) For Online Examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
