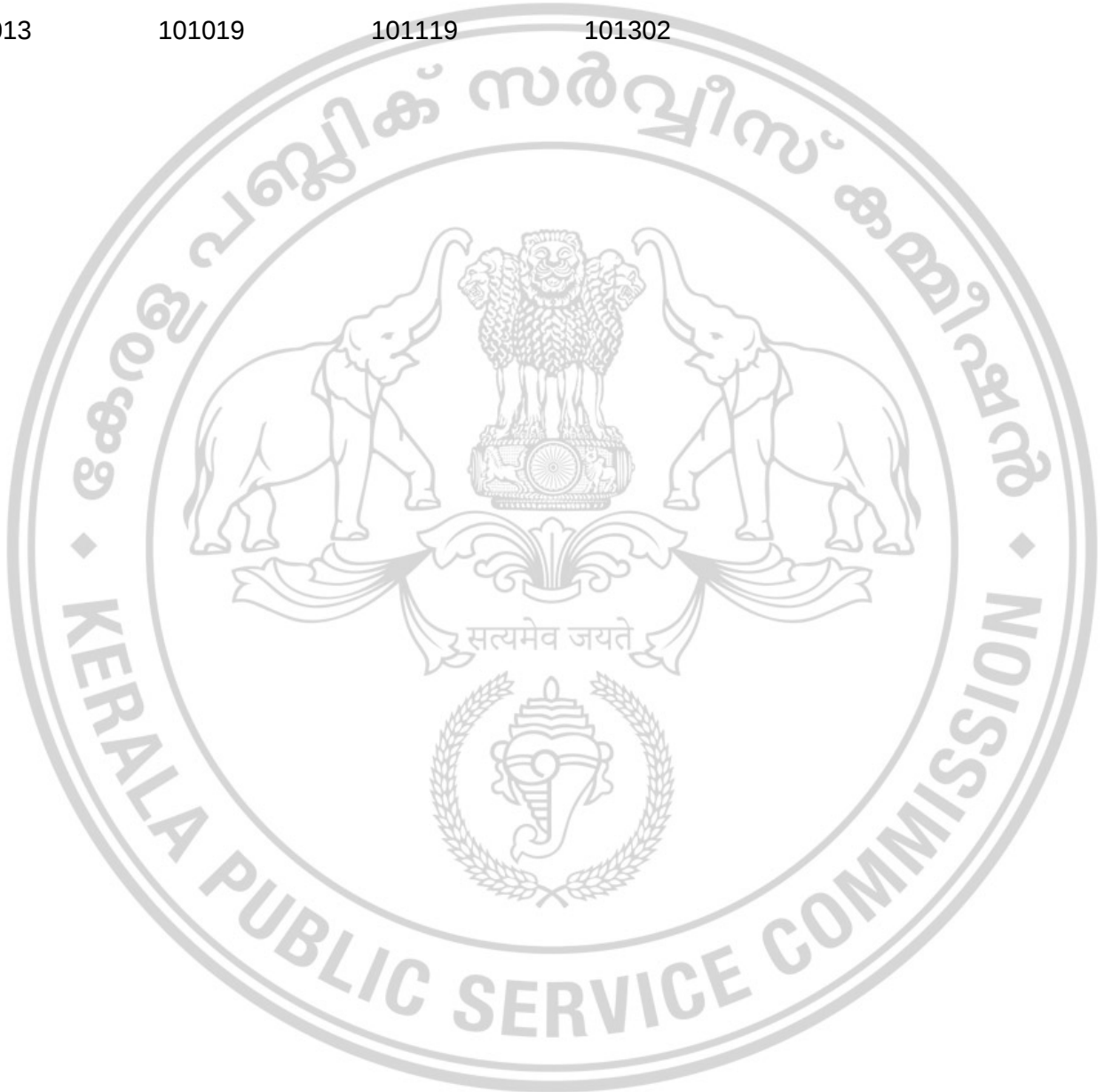

The mark secured by the last candidate in the Main List is **57.67 (Fifty seven point six seven)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribes and Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (3) Candidates included in the Short List should present and produce in person the original documents for OneTime Verification and Interview. **Date,time and Venue of OTR Verification and Interview will be intimated through profile message & SMS in due course.**

Note :- (4) The short list is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (5) At the time of One Time Verification, SC/ST Candidates included in the Short List are required to produce Community Certificate (Form III or Digitally Signed) issued by competent Revenue Authority not below the Rank of Tahsildar, candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O (P) No.81/2009/SC/STDD dated 26.09.2009 and Candidates claiming reservation under EWS Category are required to produce EWS Certificate Annexure II or Annexure IV vide G.O.(MS)No.3/2024/P&ARD dated 25.04.2024, issued by the Village Officer along with other documents.

Note :- (6) For Online Examinations, rechecking and revaluation are not allowed. But printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instruction will be furnished in the Ranked List to be published for the post
