The Marks secured by the last candidate in the Main List is **37.67 (thirty seven (point) six seven)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including available/sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and interview. **Date,time and Venue of OTR Verification and interview will be intimated through profile message in due course.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/SCSTDD Dtd.26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce Income and Asset certificate issued by Village Officer as per GO (Ms) No 03/2024 Dtd. 25.04.2024 (annexure II/IV) as proof of their claim, along with other relevant documents at the time of One Time Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 08/08/2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answerscripts are invalidated as per Notification No : **ER 2-3/10/2025-KPSC dated 27/09/2025**
