For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled tribes, Other Backward Classes and other reserved categories if any, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present in person and produce the original documents for One Time Verification and Interview. Date, time and Venue of OTR Verification and Interview will be published shortly.

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for this post.

Note :- (6) The register number of candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short list without further notice.

Note :- (7) Candidates belonging to the Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce Community Certificate either in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahasildar and candidates who claim EWS reservation are required to produce Income and Asset Certificate vide GO(Ms) No. 02/2020/P&ARD Dtd.12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **01-08-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Detailed instructions will be furnished in the Ranked list published for this post. No answer scripts are invalidated as per Notification No : ER2-3/8/2025-KPSC dated 13.10.2025.
