The marks secured by the last candidate in the Main List is 41.67 (Forty One Point Six Seven).For the purpose of satisfying the rules of reservation of appointment Scheduled Castes,Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4)Candidates included in the Short List should present and produce in person the original documents for One Time Verification and interview. Date,Time and Venue of OTR Verification and Interview will be intimated in due course.

Note :- (5) The Register Numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (6) Candidates belonging to Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated 26.09.2009 ,SC/ST candidates are required to produce a Community Certificate in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahsildar & EWS Certificate in case of candidates having EWS reservation along with other relevant documents at the time of OTR Verification.

Note :- (7)Copy of answer scripts of the OMR Test held on 04-08-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ER7-2/12/2025-KPSC Dated:18/10/2025.
