Note 5. If any of the documents produced by any candidate is found defective the Commission reserves the right for rejection of their candidature at any stage of selection as per rule.

Note 6. According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for through their one time registration profile from

the Commission's Official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/- (Rupees Eighty Five Only). The fee can be remittedby e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 days(Fifteendays) time to apply for rechecking of answer scripts will be allowed to candidates with effect from the date on which the eligibility list is uploaded in the website of the commission. The candidates can avail only one chance for rechecking after the Approval of Eligibility List within the time limit fixed above.
