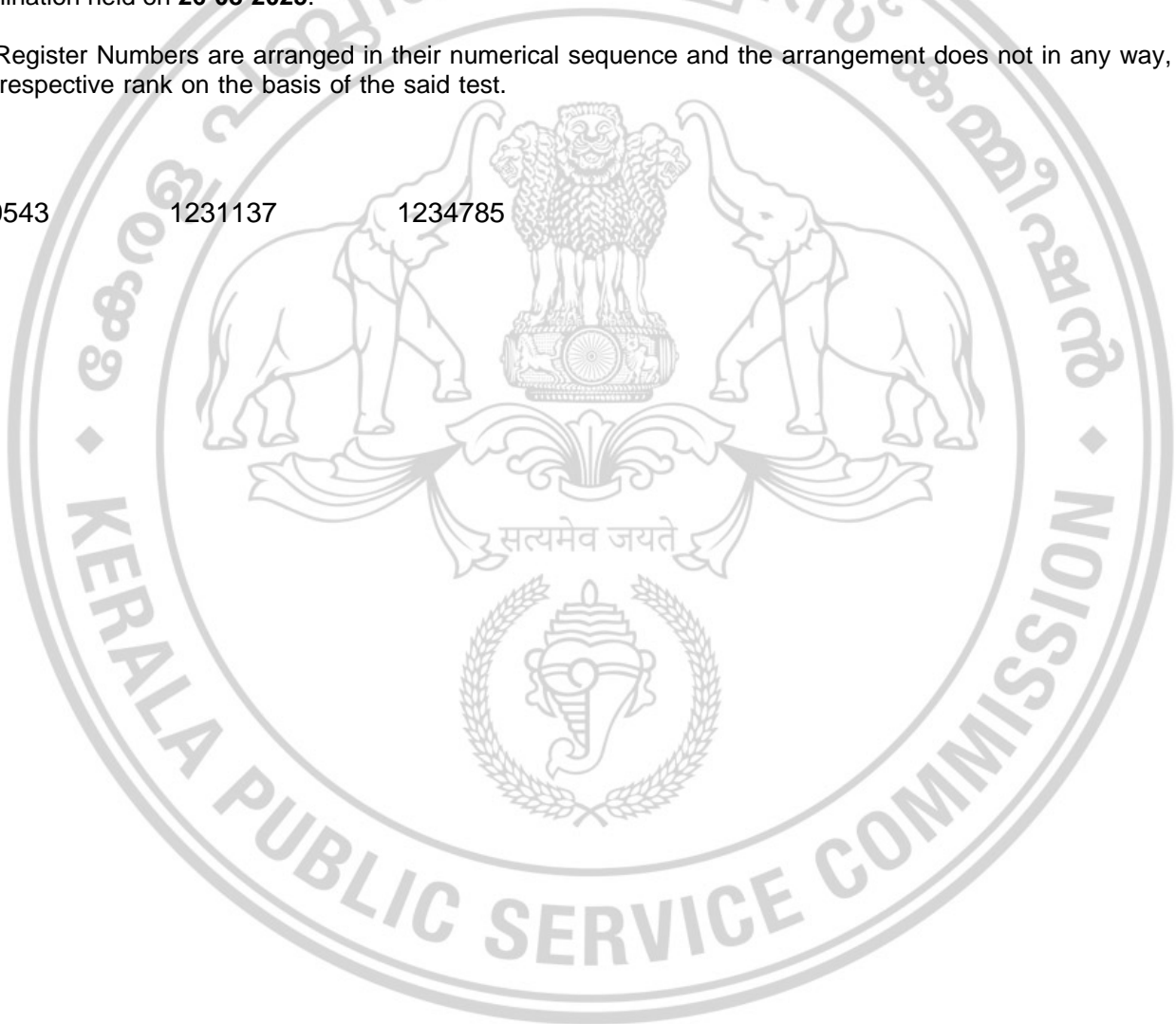

Note :- (6) Candidates included in the Short List are required to produce Community Certificate issued by the Revenue authority not below the Rank of Tahsildar at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **26-08-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No. ER7-2/14/2025-KPSC dated 12.11.2025.
