Note :- (6) Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per G.O.(P)No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt)No.3942/2018/RD dated 24.09.2018 issued by the Revenue Authority at the time of OTR Verification.
