Note :- (3) 69 (Sixty Nine) Candidates who have secured top most marks in the OMR Examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **33 (thirty three)**. For the purpose of satisfying rules of reservation of appointment to Scheduled Castes, Scheduled tribes, Other Backward Classes and Economically Weaker Section category ,necessary supplementary lists is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should be present in person for **Physical Measurement and Physical Efficiency Test** with the original ID Proof and admission ticket issued for the said test. **Date, Time and Venue of Physical Measurement and Physical Efficiency Test will be intimated through Profile Message and SMS in due course.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (6) **Candidates must possess a valid Motor Driving licence endorsed for all types of transport vehicles (LMV, HGMV & HPMV) at all the stages of selection process ie, on the last date for receipt of Application, date of OMR Test, Practical Test and Physical Efficiency Test.**

Note :- (7) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009, candidates belonging to SC/ST candidates are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahasildar and candidates belonging to Economically Weaker Sections are required to produce EWS Certificate in the format prescribed vide G.O(Ms) No.2/2020 P&ARD dated 12.02.2020 issued by the Village Officer as proof of their claim, along with other relevant documents at the time of OTR Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on 26.08.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (9) No Answer scripts are invalidated for this post as per Invalidation Notification No. ER 7-2/14/2025-KPSC Dated 12.11.2025.
