Note :- (2) The Probability list is prepared by including eligible and qualified candidates who have secured top marks in the OMR Test ,based on the details furnished by the candidates in their applications and subsequent claims made will not be entertained at any stage.

Note :- (3) **253 (Two Hundred and FiftyThree)** candidates who have secured top marks in the OMR examination held on 23-12-2021 for the post are included in the Main List of this Probability list. The Marks secured by the last candidate in the Main List is **76.67 ( Seventy Six (point) Six Seven)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes , Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be published in due course and will be intimated through profile message and SMS.**

Note :- (5) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability list without further notice.

Note :- (6) Candidates included in the Probability List who belong to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/09/SCSTDD dated. 26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar along with other documents at the time of OTR Verification. Physical fitness certificate issued by a Medical Officer not below the rank of an Assistant Surgeon should also be produced at the time of OTR Verification

Note :- (7) According to the existing procedure, revaluation of answer script is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on **23.12.2021** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer script is invalidated as per Notification **No : ERXVI(2)641/2022/EW DATED 12.05.2022** of the Secretary, KPSC
