Note :- (2) The Short list has been prepared by including the number of eligible and qualified candidates who have secured top marks in the OMR Test held on 19.08.2025, based on the details furnished by the candidates in the application for the post. Subsequent claims made will not be entertained at any stage of selection.

Note :- (3) Candidate with Register Number 1001326 is provisionally included in the Short List as per the Order of the Hon'ble Kerala Administrative Tribunal in OA No.2153/2025.

Note :- (4) **24 (Twenty Four)** candidates who have secured top most marks in the OMR examination are included in the Short list. The mark secured by the last candidate in the Short list is **36 (Thirty Six)**. **One candidate with qualification as specified in the Para 7-Note(1) of the Gazette Notification for this post is included in the List-II of the Short List. The candidate appointed under this provision will have to acquire B.Ed Degree at their own expense within five years from the date of entry in service.**

Note :- (5) Candidates included in the Short list should present and produce, in person, the original documents for One Time Verification and Interview. **Date, time and Venue of OTR Verification and interview will be intimated in due course through profile message and SMS.**

Note :- (6) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note :- (7) Candidates included in the Short List who are eligible for reservation for Other Backward Classes are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district project in the format prescribed in G.O(Rt) No 3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue Authority in the format prescribed in Kerala (Scheduled Castes and Scheduled Tribes) Regulation of issue of Community Certificates Rules, 2002 and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the revenue Authority along with other documents at the time of OTR verification of the original documents.

Note :- (8) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List notification to be published for the post.

Note :- (9) Copy of answer scripts of the OMR Test held on **19.08.2025** will be issued only to those candidates who apply for the same remitting the prescribed fee after the publication of the Ranked List. Copies of OMR sheets which are invalidated due to any defect will not be issued.

Note :- (10)) No answer scripts of Candidates are invalidated for this post vide Invalidation Notification No.ER 14-1/6/2025-KPSC Dated 17.10.2025.
