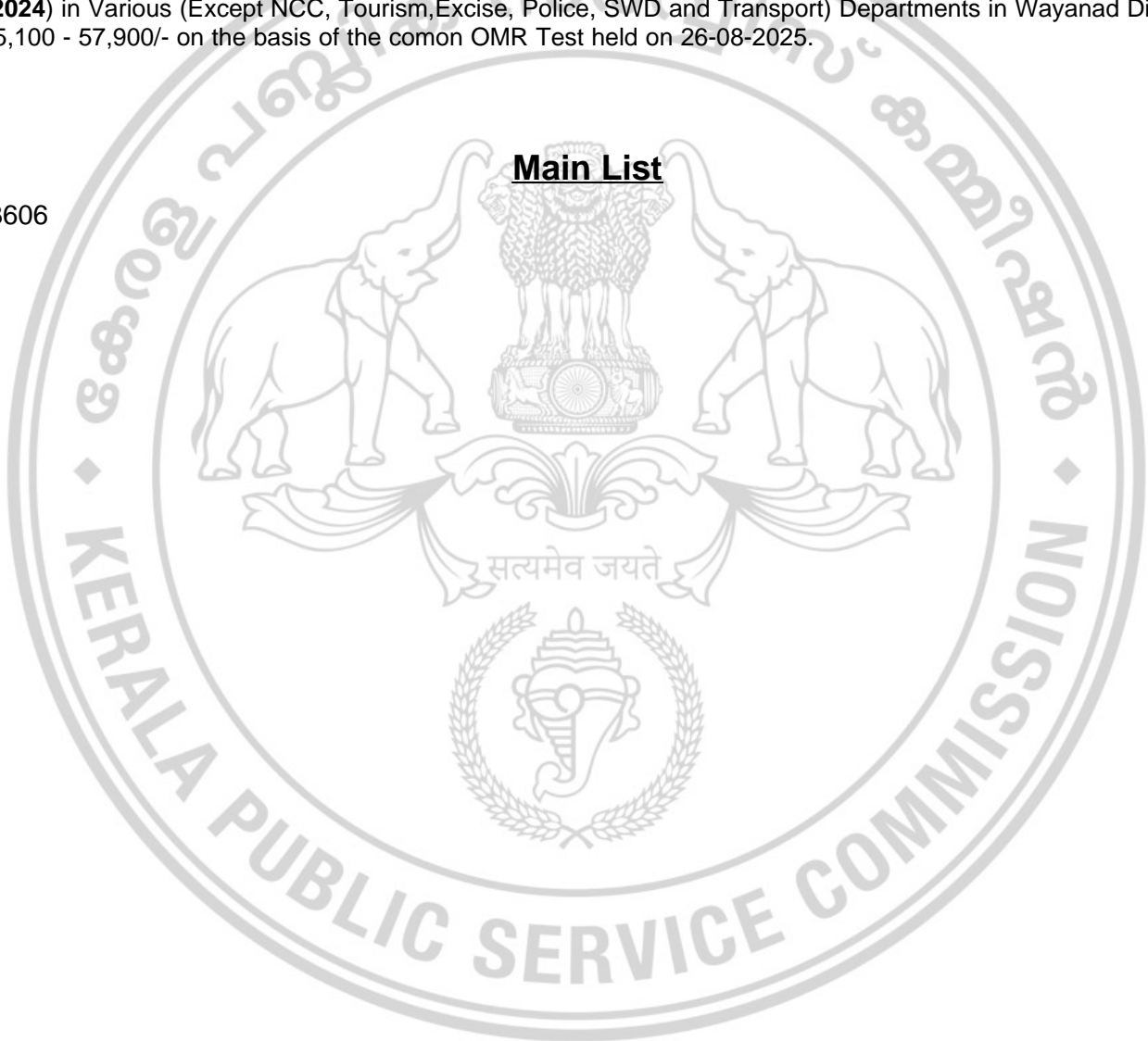

Note :- (6) According to the existing procedure, revaluation of answer script is not allowed but answer script can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Copy of answer script of the Common OMR Test held on 26/08/2025 will be issued to the candidate if he applies for the same remitting the prescribed fee only after publication of entire Ranked Lists which are to be finalized on the basis of the common test. No answer scripts are invalidated as per Notification No. ER7-2/14/2025- KPSC dated 12.11.2025.
