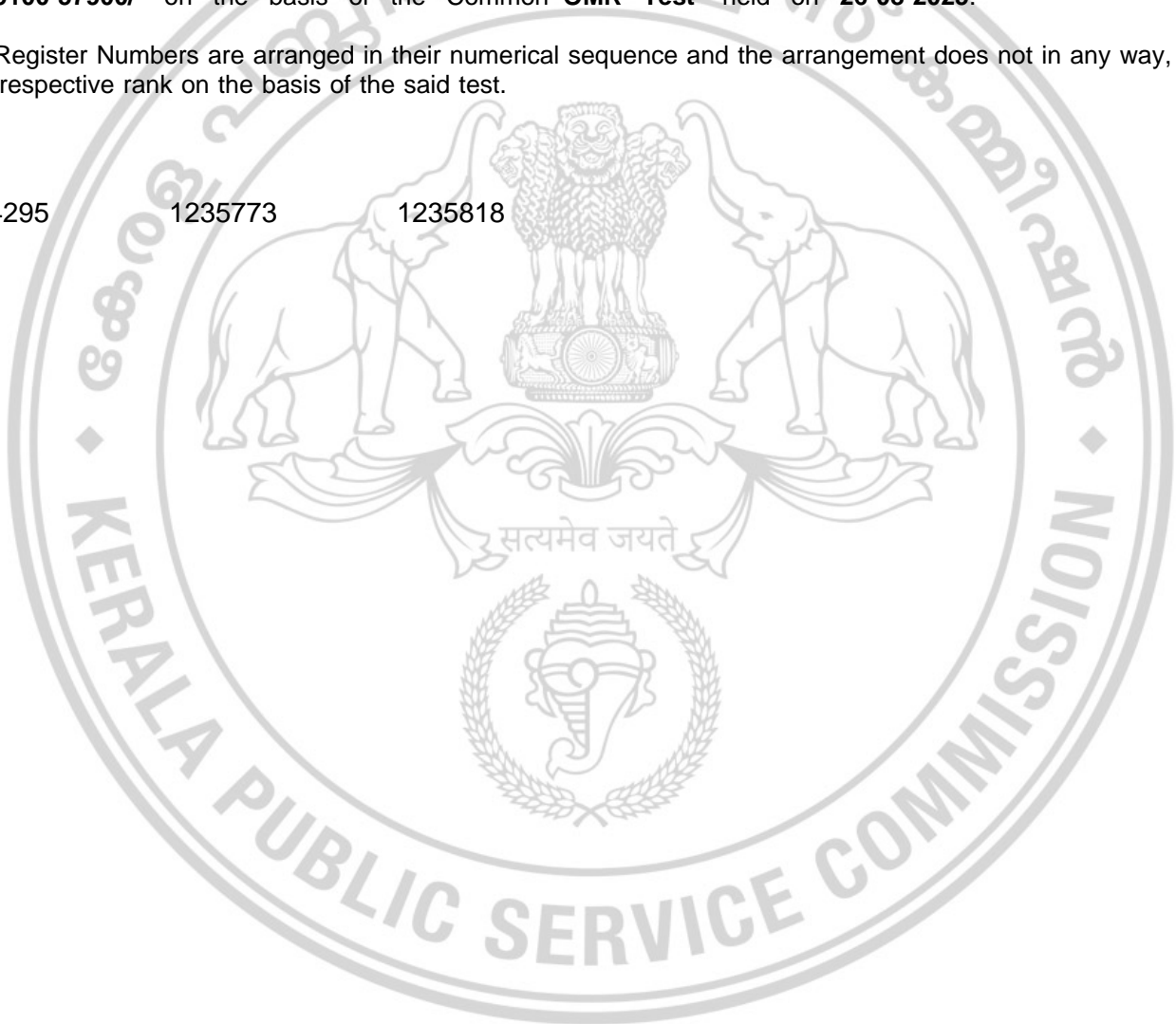

The shortlisted candidates should download their Admission Tickets for the Practical Test from their OTR profile, logging on to the official website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) of Kerala Public Service Commission and appear in person with their Admission ticket, Valid Driving Licence , Original ID Proof, Medical certificate and Service Certificate (in the form prescribed as per the Gazette notification) along with other documents at the time of Practical Test.

Note :- (5) Candidates should possess current valid Driving Licence through out all the stages of selection process i.e on the last date of receipt of application, OMR Test, Practical Test and OTV.

Note :- (6) The Register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the Common OMR Test held on 26-08-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No:ER7-2/14/2025-KPSC dated 12.11.2025 of the Secretary ,KPSC.
