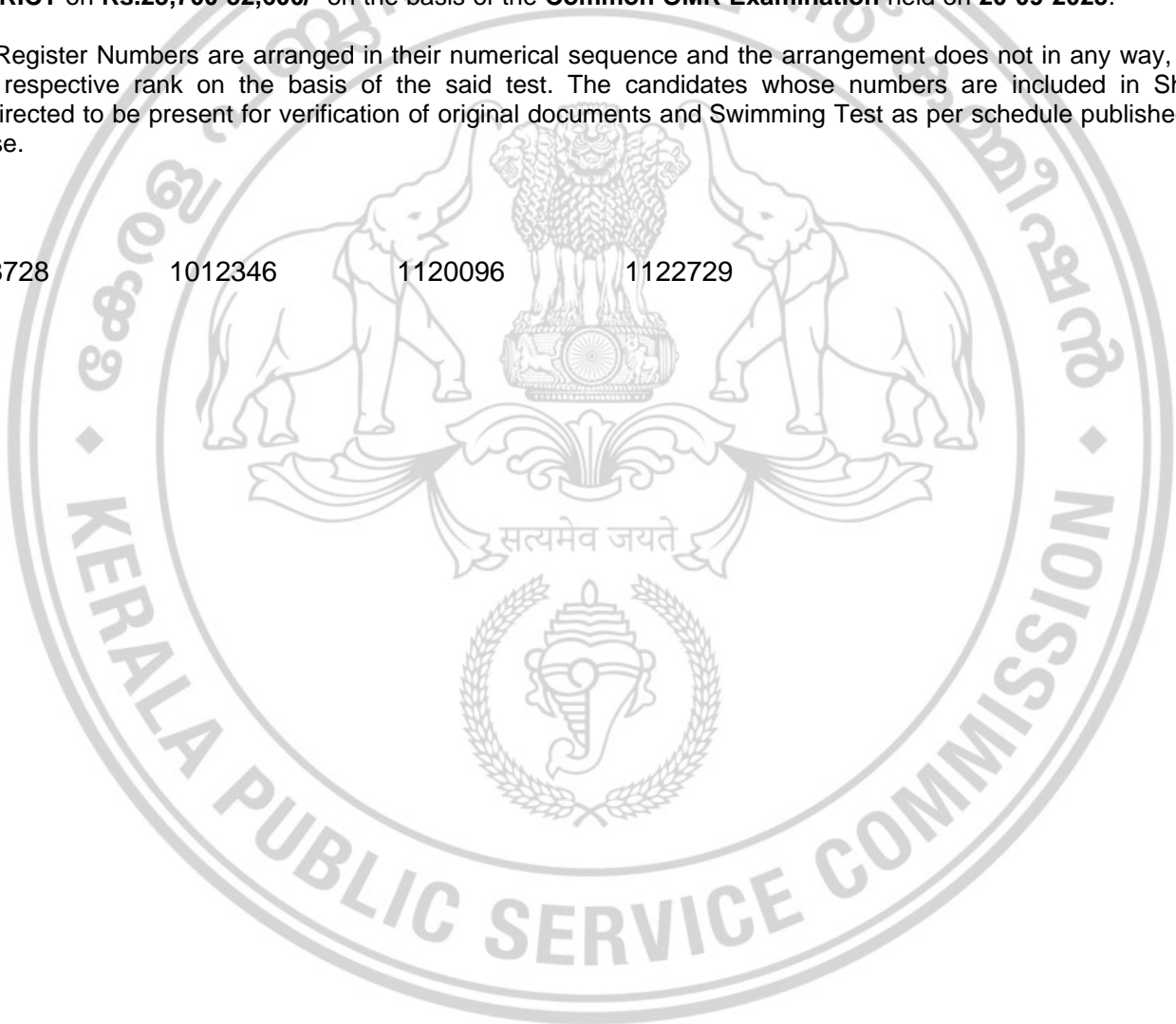

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) The Register number of those candidates who do not produce the required documents with in the prescribed time and those applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (8) Copy of answer scripts of the OMR Test held on 20.09.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No candidates are invalidated for this post as per Invalidation Notification No : ER 2-1/12/2025-KPSC dated 18.12.2025.
