### Eligibility List

**Total number of Candidates included in the Eligibility List : 242**

Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. This inclusion does not confer any right on the candidate for inclusion in the Ranked list to be prepared on the basis of the Dictation Test.

Note :- (2) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test.

Note :- (3) The candidates who have secured **43.67 ( forty three (point) six seven )** marks and above are included in the Eligibility List . The minimum marks for inclusion in the list of candidates belonging to various reservation communities have been lowered to ensure their adequate representation in the eligibility list. Candidates whose inclusion is due to the benefit of reservation to ensure adequate representation, shall have to prove their claim by producing Community Certificate/Non Creamy Layer Certificate / EWS certificate at the time of One Time Registration Verification, If they are included in the list to be published after the Descriptive (Dictation) Test . If they fail to prove their claim, their application will be summarily rejected. The marks of Differently abled candidates have also been lowered where ever necessary to ensure adequate representation. Such inclusion of Differently Abled candidates will also be subject to the production of valid documents in proof of their claim.

Note :- (4) The marks secured in the Common OMR Test by the candidate will be considered only for ascertaining the eligibility to appear for the Dictation Test and will not be considered for the purpose of final ranking and shall not have any relevance while preparing the Rank List for the post.

Note :- (5) If any of the documents produced by any candidate is found defective the Commission reserves the right for rejection of their candidature at any stage of selection as per rule.

Note :- (6) According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will berechecked if the candidates apply for through their one time registration profile from the Commission's Official website **www.keralapsc.gov.in** by remitting the prescribed fee of **Rs. 85/- (Rupees EightyFive Only)**. The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered.A period of 15 days(Fifteen days) time to apply for rechecking of answer scripts will be allowed to candidates with effect from the date on which the eligibility list is uploaded in the website of the commission. The candidates can avail only one chance for rechecking after the Approval of Eligibility List within the time limit fixed above. Rechecking of answer scripts invalidated due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded. Candidates who have submitted the application for rechecking of the OMR answer scripts will be informed of their results through profile message only. Such message can be viewed by logging on to their `One Time Registration` profile using their User ID and Password.

Note :- (7) Candidates who wish to obtain a photocpy of their OMR Answer sheets (Part A & Part B) relating to the selection shall submit online application through their One Time Registration profile from the official website of the Commission, **www.keralapsc.gov.in** by remitting the prescribed fee of **Rs.335 (Rupees Three Hundred and ThirtyFiveonly)** via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Eligiblity List is uploaded in the website ofthe Commission. Application submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to the candidate. Copies of OMR sheets invalidated due to any defect will not be issued.
