Note 1. Inclusion of register numbers in this list is purely provisional. This inclusion does not confer any right on the candidate for inclusion in the Ranked list to be prepared for the post.

Note 2 . The List is prepared based on the details furnished by the candidates in the application and subsequent claims made will not be entertained at any stage.

Note 3. The Eligibility List has been prepared by including the register numbers of candidates who have secured top marks in the OMR Test. The candidates who have secured **15 (Fifteen) Marks** and above in the OMR test are included in the eligibility list. The minimum marks for inclusion in the list of candidates belonging to various reservation communities have been lowered to ensure their adequate representation in the eligibility list. Candidates whose inclusion is due to the benefit of reservation to ensure adequate representation, shall have to prove their claim by producing Community Certificate /Non Creamy Layer Certificate at the time of One Time Verification, if they are to be included in the list to be published after the Dictation Test. If they fail to prove their claim, their application will be summarily rejected. The marks of Differently abled candidates have also been lowered where ever necessary to ensure adequate representation. Such inclusion of Differently Abled candidates will also be subject to the production of valid documents as proof of their claim.

Note 4. The Dictation Test and One Time Verification will be conducted before the publication of the Ranked List. Date, Time and Venue of Dictation Test and Certificate Verification will be intimated through profile message and SMS in due course. The candidates should download the Admission Tickets from the official website (www.keralapsc.gov.in) of KPSC and appear in person with their original ID Proof and other required documents for Dictation Test.

Note 5. If any of the documents produced by any candidate is found defective the Commission reserves the right for rejection of their candidature at any stage of selection as per rule.

Note 6. According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for through their one time registration profile from the Commission's Official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/- (Rupees Eighty Five Only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner (ie, via E-Mail/Tappal/Direct) will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of answer scripts will be allowed to candidates with effect from the date on which the eligibility list is uploaded in the website of the commission. The candidates can avail only one chance for rechecking after the Approval of Eligibility List within the time limit fixed above. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded. Candidates who have submitted the application for rechecking of the OMR answer scripts will be informed of their results through profile message only. Such message can be viewed by logging on to their 'One Time Registration' profile using their User ID and Password.

Note 7. Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to the selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs.335/- (Rupees Three Hundred and Thirty Five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates.

Note 8. No answer scripts are invalidated as per Notification No. ER16-1/17/2025-KPSC dated 04.12.2025..
