

The marks secured by the last candidate in the Main List is **56.67 (Fifty Six (point) Six Seven)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Sections, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belong to such classes.

Note :- (4) **Practical Test** will be conducted for candidates included in the Short List. **Date, Time and Venue** will be intimated in due course.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belong to SC/ST Community included in the Short List are required to produce Community Certificate issued by the Revenue authority and candidates belong to Other Backward Classes included in the Short List are required to produce Non-Creamy Layer Certificate issued by the Revenue authority and candidates belong to EWS category are required to produce EWS certificate issued by the Revenue Authority at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **26-08-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated for the above post vide Notification No : **ER7-2/14/2025-KPSC Dated 12.11.2025**.
