Note:- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Probability List does not confer any right on the candidate for inclusion in the Ranked List.

Note:- (2) The Probability list is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (3) **10 (Ten)** candidates who have secured top most marks in the OMR Examination are included in the Main List of the Probability List. The marks secured by the last candidate in the Main List is **66 (Sixty Six)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should be present in person and produce the original documents for One Time Verification. Date, time and Venue of One Time Verification will be intimated through profile message/ SMS in due course.

Note:- (5) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability list without further notice.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates included in the Probability List belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by the Village Officer as per G.O. (P) No. 81/09/SCSTDD dated 26.09.2009. Candidates belonging to SC/ST communities are required to produce Community Certificate either in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahasildar and Candidates belonging to Economically Weaker Section are required to produce Income and Asset Certificate issued by the Village Officer in the format prescribed vide G.O (MS) No. 3/2024/P&ARD dated 25.04.2024 as proof of their claim, alongwith other documents at the time of One Time Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on 11-10-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : **ER7-1/9/2025-KPSC dated 17.12.2025**.
