Note:- (3) 09 (Nine) candidates who have secured top most marks in the OMR examination are included in the Main List of this Probability list. The Marks secured by the last candidate in the Main List is **86.67** (Eighty Six (point) Six Seven). For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes if any, necessary Supplementary Lists have been prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes. marks and above are included in the Probability List.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date, Time and Venue of OTR Verification will be published in due course through Profile message and SMS.**

Note:- (5) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note:- (6) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Thahsildar and candidates belonging to Economically Weaker Section are required to produce EWS Certificate vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the competent authority at the time of OTR verification.

Note:- (7) According to the existing procedure, revaluation of answer script is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:- (8) Copy of answer scripts of the OMR Test held on **20-09-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No: **ER2-1/12/2025-KPSC** Dated **18-12-2025** of Secretary KPSC, Tvpm.
