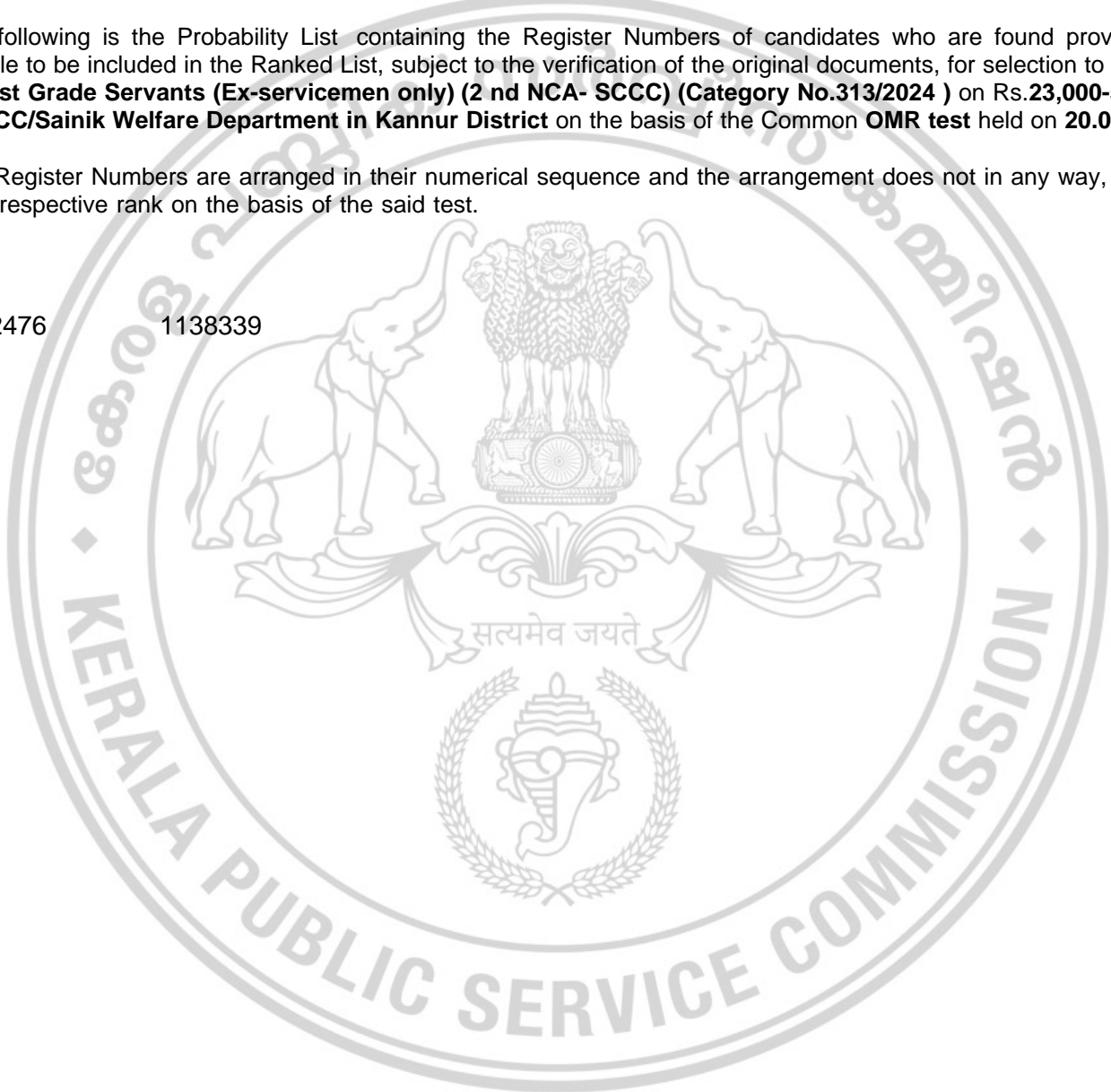

Note :- (6) The Register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of candidates who have appeared for the OMR Test held on 20.09.2025 for the post will be issued to those candidates who, apply for the same remitting the prescribed fee after the publication of Ranked List. No Answer Scripts of the Candidates are invalidated as per Notification No : ER2-1/12/2025-KPSC dated 18-12-2025 of the secretary, Kerala Public Service Commission , Thiruvananthapuram.
