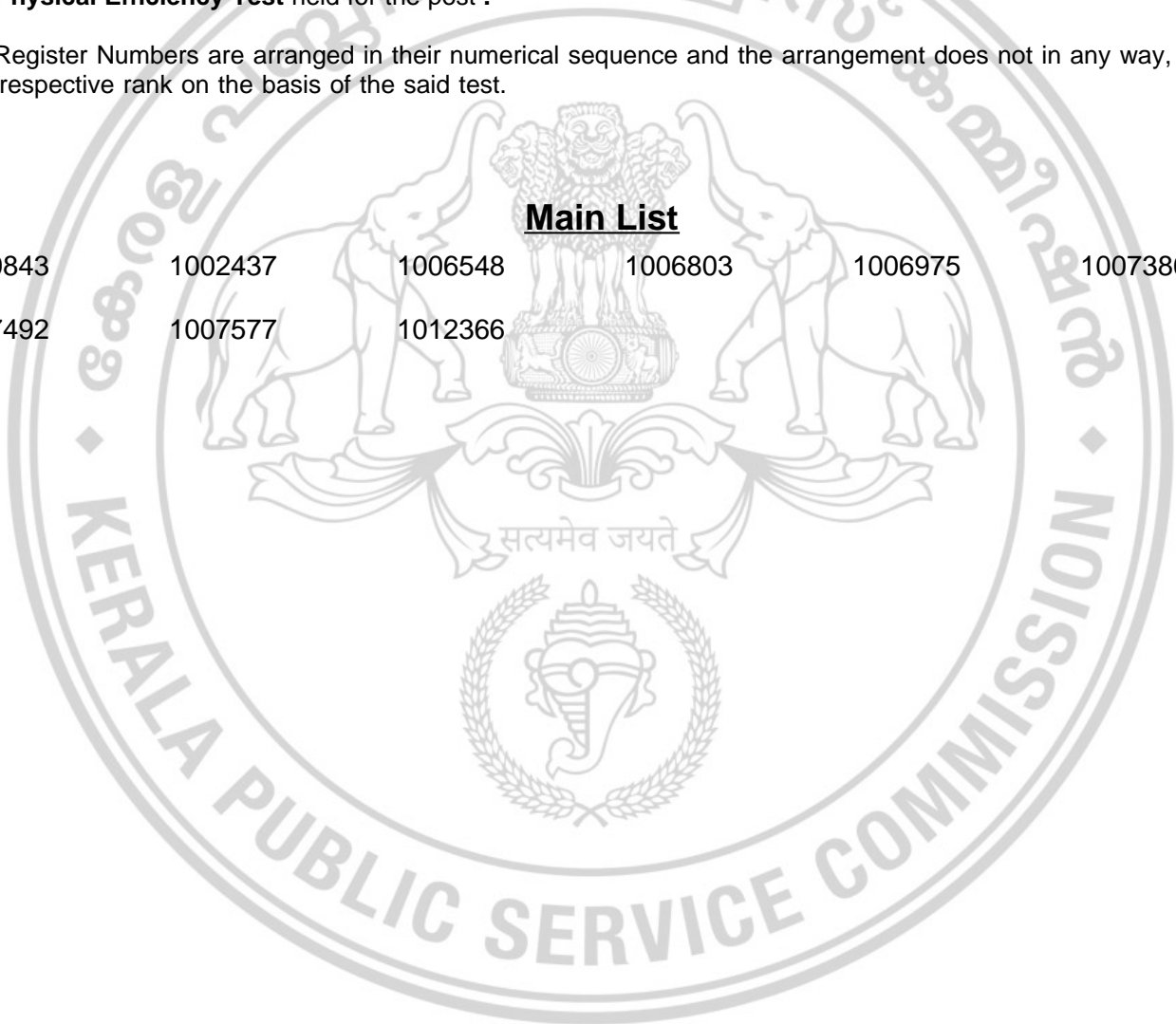

Note :- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (5) Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per GO(P)81/09/SCSTDD dated 26.09.2009 issued by Village Officer along with other documents at the time of OTR verification. **Candidate must possess valid driving licence with endorsement for driving heavy goods vehicle or heavy passenger vehicle with badge throughout all the stages of selection; ie, on the last date of receipt of application, date of OMR test, date of physical efficiency test and practical test.** The candidates are required to produce latest extract of driving licence at the time of OTR verification.

Note :- (6) Copy of answer scripts of the OMR Test held on 15.07.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after the publication of the Ranked List.
