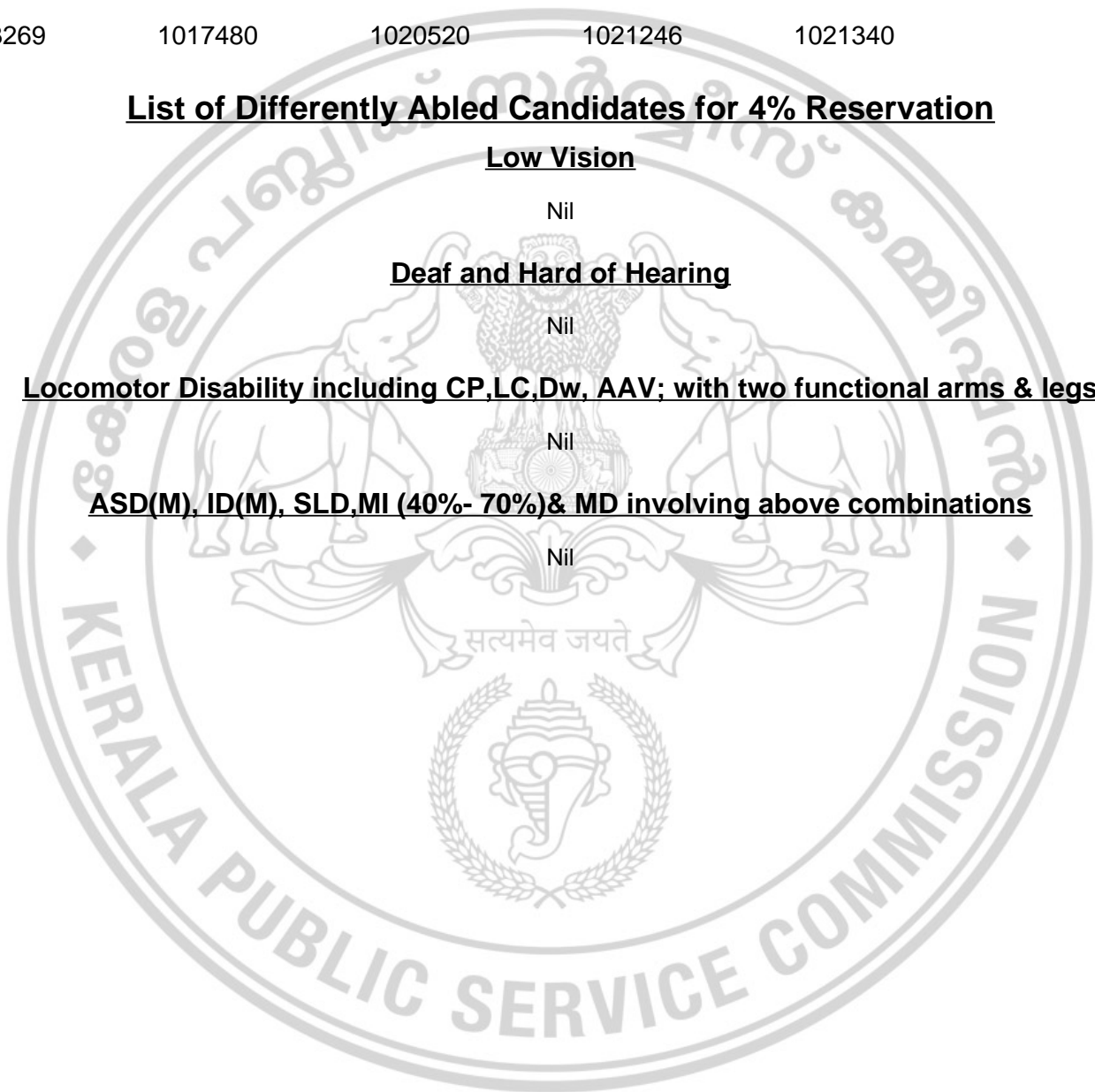

Note:- (2) The Probability List is prepared by including eligible and qualified candidates who have secured top marks in the OMR test based on the details furnished by the candidates in their applications and subsequent claims made will not be entertained at any stage of the selection

Note :- (3) **9(Nine)** candidates who have secured top most marks in the OMR Examination for the post held on **26.09.2025** are included in the Main List of this Probability List. The marks secured by the last candidate in the Main List is **77.33 (seventy seven (point) three three)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes , Other Backward Classes and Economically Weaker Sections (and other reserved categories if any) necessary supplementary lists are prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Probability List without further notice

Note:- (5) Candidates included in the Probability List should be present in person and produce the original documents for One Time Verification. Date and time of OTR Verification will be intimated through profile message and SMS in due course.

Note :- (6) Candidates included in the Probability List and belonging Other Backward Classes are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O.(P) No. 81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahsildar and candidates belonging to Economically Weaker Section are to produce EWS Certificate in the format prescribed vide GO(Ms) No.3/2024/P&ARD dated 25.04.2024 issued by the Village Officer as proof of their claim, along with other relevant documents at the time of OTR verification.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of candidates who have appeared for the OMR Test held for the post on **26-09-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after the publication of the Ranked List. No answer scripts of the candidates are invalidated as per Notification No: **ER 2-3/12/2025-KPSC Dated 25.11.2025** of the Secretary, Kerala Public Service Commission
