

Note :- (2) The Short List is prepared based on the details furnished by the candidates in their applications and subsequent claims made will not be entertained at any stage.

Note :- (3) 150 (One Hundred and Fifty) candidates who have secured top marks in the OMR Test held for this post on 21.11.2025 are included in the Main List of this Short List. The mark secured by the last candidate in the Main List is 23.67 (Twenty Three (point) six seven). For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled tribes, Other Backward Classes and other reserved categories if any, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should appear in person and produce the original documents for One Time Verification. **Date,time and Venue of OTR Verification, physical measurement and cycling test of candidates included in the Short List will be intimated through Profile Message/SMS in due course.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for this post.

Note :- (6) The register number of candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the List without further notice.

Note :- (7) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahasildar and candidates who claim EWS reservation are required to produce Income and Asset Certificate in the format prescribed vide G.O(Ms) No.2/2020 P&ARD dated 12.02.2020 issued by the Revenue Authority along with other relevant documents at the time of OTR Verification of original documents.

Note :- (8) Copy of answer scripts of the OMR Test held on **21-11-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER 2-1/ 13/2025-KPSC dated 14/01/2026 of the Secretary, Kerala Public Service Commission.
