

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of candidates who have appeared for the OMR Test held on 17.11.2025 for the post, will be issued to those candidates who apply for the same remitting the prescribed fee after the publication of the Ranked List.
