

Note :- (6) Candidates included in the Short List are required to produce Community Certificate (Form III or Digitally Signed) issued by the Revenue authority not below the rank of a Tahsildar in proof of their claim along with other relevant documents at the time of One Time Verification of original documents

Note :- (7) Copy of answer scripts of the OMR Test held on **29-12-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
