

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for **One Time Verification. Date, Time and Venue of One Time Verification will be intimated through profile message & SMS** in due course.

Note:- (5)The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of the Ranked List.Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates included in the Probability List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/SCSTDD Dtd.26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce Income and Asset certificate issued by Village Officer as per GO(Ms) No. 2/2020/P&ARD Dtd. 12.02.2020 as proof of their claim, along with other relevant documents at the time of One Time Verification of original documents.

Note :- (8)Copy of answer scripts of the OMR Test held on 15-11-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.No answer scripts are invalidated as per Notification No:ER2-3/1/2026-KPSC Dated 28.01.2026.
