Note:-(4) Dependents of EX-Service personnel/Defence Service personnel should submit the self attested true copy if certificate and original of the same from the concerned Tahasildar as and when called for and in the absence of such certificate from Tahasildar,a certificate,self attested true copy of the same obtained from the concerned Commanding Officer proving the relationship of the applicant with the Defence service personal,his name,Rank in Military,address in Military etc..will be sufficient.

Note:-(5) The Register Number of those candidate who have not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published for the post.

Note:- (7) The Probability list is prepared based on the details furnished by the candidates in the application and subsequent claims if any, made will not be entertained at any stage.

Note:-(8)Copy of answer scripts of the OMR Test held on **27.10.2025** will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates have been invalidated as per Notification No : ER 16-2/10/2025-KPSC Dated:31.12.2025.
