

Note:- (2) The Probability List has been prepared by including the number of Eligible and Qualified candidates who have secured top marks in the OMR Test held on 3.12.2025, based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage of selection.

Note :- (3) **10 (Ten)** candidates who have secured top most marks in the OMR Examination are included in the Main List of this Probability List. The marks secured by the last candidate in the Main List is **62 (Sixty Two )** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary Supplementary List is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date,time and Venue of OTR Verification will be published shortly.

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in the Probability List are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/09/SC/STDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in G.O(Rt) No.3942/2018/RD dated 24.09.2018 and SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate issued by Village Officer as per G.O.(MS) No. 2/2020/P&ARD dated 12.02.2020 along with other documents at the time of OTR Verification.

Note :- (7) The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note :- (8) Copy of answer scripts of the OMR Test held on 3.12.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after the publication of Ranked List. No Answer Scripts of Candidates are invalidated as per Notification No : ER 8-1/1/2026-KPSC Dated 10.2.2026.
