Note :-(3) **107 (One Hundred and Seven)** candidates who have secured top most marks in the OMR examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **48.33 (Forty Eight(Point)Three Three)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section , necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :-(4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview . **Date,time and Venue of One Time Verification and Interview will be intimated through Profile Message and SMS.**

Note :-(5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :-(6) Candidates included in the Short List belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by the Village Officer as per G.O. (P) No. 81/09/SCSTD dated 26.09.2009.Candidates belonging to SC/ST communities are required to produce Community Certificate either in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahasildar and Candidates belongingto Economically Weaker Section are required to produce EWS certificate in the format prescribed vide GO(Ms) No.5/2020/P&EA dated 04.03.2020 along with other relevant documents at the time of One Time verification.

Note :-(7) Copy of answer scripts of the OMR Test held on **20-11-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ER6-2/10/2025-KPSC dated 10/02/2026.
