Note:- (2) The Probability list is prepared by including eligible and qualified Candidates who have secured top marks in the Online Examination held on 12-11-2025 for the post, based on the details furnished by the candidates in their applications and subsequent claims made will not be entertained at any stage.

Note :- (3) 10 (Ten) eligible and qualified candidates who have secured top most marks in the Online Examination held for the post on 12-11-2025 are included in the Main List of the Probability List. The marks secured by the last candidate in the Main List is 60.67 (Sixty (point) six seven). For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date, time and Venue of OTR Verification will be informed through profile message and SMS in due course.

Note:- (5) Candidates included in the Probability List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/SCSTDD Dtd.26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS certificate issued by Village Officer as per GO (Ms) No. 03/2024 Dtd. 25.04.2024 as proof of their claim, along with other relevant documents at the time of One Time Verification.

Note:- (6) The register numbers of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the probability list without further notice.

Note :- (7) For Online Examination, rechecking and revaluation are not allowed but print out of the answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of the Ranked List. Detailed instructions will be furnished in the Ranked list to be published for the post.
