

Note :- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Short List does not confer any right on the candidate for inclusion in the Ranked List.

Note :- (2) The Short list has been prepared by including the number of eligible and qualified candidates who have secured top marks in the OMR Test held on 24.10.2025, based on the details furnished by the candidates in the application for the post. Subsequent claims made will not be entertained at any stage of selection.

Note :- (3) **13(Thirteen)** candidates who have secured top most marks in the OMR examination are included in the Short list. The mark secured by the last candidate in the Short list is **57.33 ( fifty seven (point) three three)**. For the purpose of satisfying the rules of reservation of appointment to various available reservation groups, necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short list should present and produce, in person, the original documents for One Time Verification and Interview. **Date, time and Venue of OTR Verification and interview will be intimated in due course through profile message and SMS.**

Note :- (5) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates included in the Short List who are eligible for reservation for Other Backward Classes are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in G.O(Rt) No 3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue Authority in the format prescribed in Kerala (Scheduled Castes and Scheduled Tribes) Regulation of issue of Community Certificates Rules, 2002 and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the revenue Authority along with other documents at the time of OTR verification of the original documents.

Note :- (8) Copy of answer scripts of the OMR Test held on 24.10.2025 will be issued only to those candidates who apply for the same remitting the prescribed fee after the publication of the Ranked List. Copies of OMR sheets which are invalidated due to any defect will not be issued.

Note :- (9) ) No answer scripts of Candidates are invalidated for this post vide Invalidation Notification No.ER15-3/12/2025-KPSC Dated 21.02.2026.
