

Note :- (3) 283 (Two Hundred and Eighty Three) candidates who have secured topmost marks in the Common OMR Examination held on 09.08.2025 are included in the Main List of the Probability List. The marks secured by the last candidate in the Main list is **66 (sixty six)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, if any, necessary Supplementary List is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should be present in person and produce the original documents for One Time Registration Verification. Date,time and Venue of OTR Verification will be informed in due course through Profile message and SMS.

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahasildar and candidates belonging to Economically Weaker Sections are required to produce EWS Certificate in the format prescribed vide G.O(Ms) No.5/2020/P&EA dated 04.03.2020 issued by the Village Officer as proof of their claim, along with other relevant documents at the time of OTR Verification.

Note :- (7) The Register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose Applications are found otherwise defective will be deleted from the Probability List without further notice.

Note:-(8) Copy of answer scripts of the OMR Test held on 09.08.2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note:- (9) Candidates whose Register Numbers are invalidated are advised to refer to Notification No.ER16-1/6/2025-KPSC Dated 20.11.2025.
