

Note:- (1) Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of application on absolute basis. Inclusion of Register numbers in the Probability List does not confer any right on the candidate for inclusion in the Ranked List.

Note:- (2) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test based on the details furnished by the candidates in the application and subsequent claims made will not be entertained at any stage.

Note :- (3) **15 (Fifteen)** candidates who have secured top most marks in the OMR Examination are included in the Main List of the Probability List. The marks secured by the last candidate in the Main List is **49.33 (forty nine(point) three three)** marks. For the purpose of satisfying the rule of reservation of appointment of Scheduled Caste, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date,time and Venue of OTR Verification will be informed through profile message in due course.

Note:- (5) Candidates included in the Probability List and belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by Village Officer as per GO(P) No.81/2009/SCSTDD Dtd.26.09.2009, SC/ST Candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of Community Certificate Rules 2002 by the Revenue authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce Income and Asset certificate issued by Village Officer as per GO (Ms) No.2/2020/P&ARD dated 12/02/2020 as proof of their claim, along with other relevant documents at the time of One Time Verification.

Note :- (6) Candidates included in the Probability List are requested to produce the latest Physical Fitness certificate in the prescribed format at the Time of One Time Verification.

Note :- (7) The register numbers of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the probability list without further notice.

Note :- (8) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (9) Copy of answer scripts of the OMR Test held on **27-10-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification **No:ER16-2/10/2025-KPSC Dated 31.12.2025**.
