Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Probability List are required to produce a certificate from the

concerned Tahsildar and in the absence of such certificate from the Tahsildar, a certificate obtained from the concerned Commanding Officer proving the relationship of the applicant with the Defence Service Personnel, his name, Rank in Military, address in Military etc. along with other documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the Common OMR Test held on **27-10-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answerscripts have been invalidated as per **Notification No:- ER 16-2/10/2025-KPSC dated 31.12.2025 of the Secretary, KPSC.**
